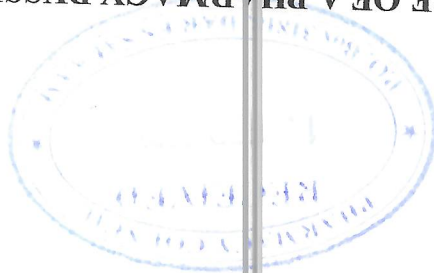

In light of a great loss incurred by our bussiness due to low volume of sales, I the undersigned, the owner of **Dipela Pharmacy** located at Plot No. 723/12, Mwananyamala, Kinondoni Dar Es Salaam, constrained to close the operations effective from the end of January 2024.

In view of such closure, my position as a superintendent of Dipela Pharmacy together with other employee cease to exist effective thereafter.

As we understand the danger to public health and risk to the environment of poor disposal of medicinal products, arrangement for the redistribution of the leftover medicines and medical supplies is already in place. We left with very few products and this stock is of merchantable quality, are therefore going to be transferred to a nearby pharmacy as the attached letter explain.

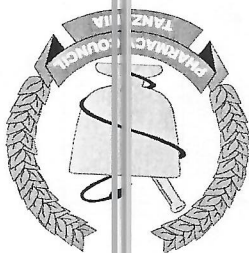

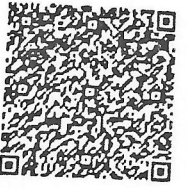
