CONTRACT OF EMPLOYMENT

The Employer offers employment to the Employee, and the Employee accepts this offer of employment, on the terms and conditions specified in the Contract of Employment and signed by the Employer and Employee. This Contract (Version 2018), which incorporates the new Employment and Labour Relations Act 2004, is issued to all staff. A copy of this contract can be provided for reading in case anyone has lost her/his original copy.

3. Duties, Regulations of Employment and Annual Leave

3.1 Duties

Each employee will have a job description, as addendum to the contract of employment. The Job description may be amended by **Employer** whenever it is necessary.

3.2 Regulations of Employment

The employee shall serve the employer in accordance with regulations stated in this Contract, and in accordance with any other management documents provided (management guide, finance rules) under separate cover, as an integral part of this Contract of Employment.

3.3 Annual Leave

Upon completion of eleven months of service with **Employer**, the employee is entitled to an annual leave of 28 calendar days with full pay. Each employee will receive an annual leave travel allowance, the amount of which shall be specified from time to time.

4. Remunerations

(i) During the continuance of this Agreement the employee's Gross salary **TZS 700,000/=** per calendar month

Deductions will be applicable in accordance with the current tax Laws and statutory contributions,

The salary shall be payable at the end of the month or in advance before the due day on a mutually agreed day and, if such day is not agreed, at least once on completion of half a month of service.

5. Terminations of Contract and Notice

The employer shall have: the right to terminate the employment of the employee provided that the reason for the termination is related to the employees conduct, capacity or compatibility or is based on the operational requirements of the employer including any financial constraints that may necessitate the Employer to terminate this contract.

The employer shall give the employee one-month notice or one-month salary in lieu of such notice. Provided that the employee will not receive a one-month salary in lieu of notice in the event that the termination by the employer was on disciplinary grounds and constitutes fair termination under the terms of the Labour Relations Act 2004.

The employee, likewise, may terminate the employment by giving one-month notice or paying one-month gross salary in lieu thereof.

6. Changes to the Version 2018, Jurisdiction and Copies of the Contract All changes effected in these terms of employment are in accordance with the new Employment and Labour Relations Act, 2004.

7. Jurisdiction of the Contract

7.1 Jurisdiction

The construction, performance and interpretation of this Agreement shall be governed by the laws of the United Republic of Tanzania in general, and the terms within the LOTUS PHARMA (T) LIMITED Contract in particular.
