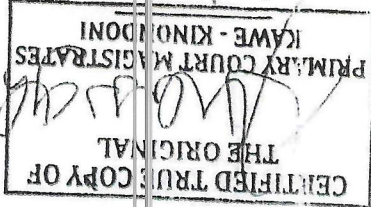

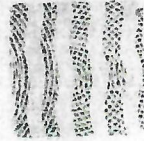

In view of the above, since this case has been full of excuses and the same being a backlog case since 2021, by virtue of Order IX Rule 5 CPC, I dismiss it for no litigation is to stay in court forever.
It is accordingly ordered.
