Please find enclosed the premise registration certificate, renewed permit, and change of management forms for the pharmaceutical technician.

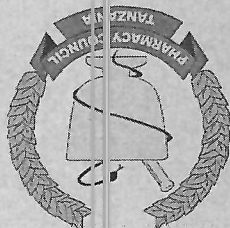

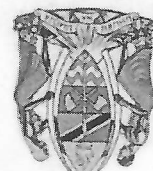
