Vile vile uuzaji wa dawa itwayo "Misoprositol" ambayo nimezuia isiuzwe bila kuwa na prescription ya Daktari umeendelea kufanyika bila kufuata maelekezo. Mmiliki mwenyewe ambaye pia ni Daktari amekuwa mstari wa mbele kupinga maelekezo akilazimisha dawa ya "Misoprositol" iuzwe kwa watu wanaotaka kutoa mimba huku akidai atawatengenezea taarifa za kughushi. Aidha amekwamisha uwekaji wa nyaraka muhimu katika eneo la wazi kama Business Permit na Premises Registration Certificate. Kufikia tarehe 09/06/2025 ni mda mrefu umepita tangu nyaraka hizo zimepatikana lakini alipojulishwa hakuwa tayari kununua fremu kwa ajili ya kuziweka. Vile vile katika mazungumzo kupitia simu tuliyoyafanya mara ya mwisho nilipomuonya ameonesha kuwa mtu mwenye hasira kwangu akilazimisha kwa nguvu mitazamo yake ifuatwe. Jambo hilo limenitia wasiwasi juu ya usalama wangu hivyo nitashindwa kufika katika Famasi yake bila kuwa na ulinzi.
