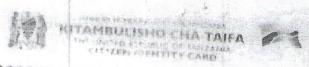

COMPANY LIMITED BY SHARES MEMORANDUM OF ASSOCIATION

OF

MEDMARK PHARMACY LIMITED.

1. The name of the company MEDMARK PHARMACY LIMITED. (the "Company").

2. The registered office of the Company shall be situated on the mainland part of the United Republic of Tanzania.

3. The objects for which the company is established are:-

- a. To carry on the business of retail and wholesale pharmacy, including the sale of prescription and non-prescription medicines, health products, and medical supplies.
- b. To provide healthcare consultation and advisory services.

c. To collaborate with healthcare professionals and organizations to promote public health.

- d. To act as representative, Agent, Sub Agent, Commission Agent of in Tanzania for the government and corporate entities in Tanzania and other foreign Companies, Firms, persons, states and other bodies Corporates and to represent them before the different authorities Corporates and bodies and to act as their sales, purchase representatives and to render services to them for transporting warehousing, distributing, and maintaining all types of goods and equipments in good conditions supplied by the Principals.
- e. To acquire by purchase, exchange or otherwise any movable or immovable property any rights or privileges which the Company may deem necessary or convenient for the purpose of its main business.
- f. To hire on suitable terms the Company's technicians, experts and others, to parties in the United Republic of Tanzania, and or outside Tanzania for development and smooth operation of the Company.
- g. To enter into partnership or into any arrangement for sharing profits, union of interest, Joint venture, reciprocal concession or co-operation with persons or Companies carrying on or engaged in the main business or transaction of this Company.
- h. To apply for, purchase, or otherwise acquire, and protect and renew in any part of the world any patents, patent rights, inventions, trademarks, designs, licences, concessions and the like, conferring any exclusive or non-exclusive or limited rights, their use, or any secret or other information as to any invention which may seem capable of being used for any of the purpose of the Company or the acquisition of which may seem calculated directly or indirectly to benefit the Company, and to use, exercise, develop or grant licences in respect of, or otherwise, turn to account the property, rights or information so acquired, and to expend money in experimenting upon, testing or improving any such patents, inventions or rights and without prejudice to the generality of the above, any contracts, or in relation to the supply and sale of any materials,

The expressions "Debenture" and "Debenture holder" shall include "Debenture Stock" and "Debenture Stockholder", and the expression "Secretary" shall include a temporary or assistant Secretary and any person appointed by the Directors to perform any of the duties of the Secretary.

Save as aforesaid any words or expressions defined in the Act shall, if not inconsistent with the subject or context, bear the same meaning in these presents.

The marginal notes are inserted for convenience only and shall not affect the construction of these presents.

Words importing the singular number only shall include the plural and the converse shall also apply.

Words importing males shall include females.

- 3. The Company is a private company and accordingly:
 - a) the right to transfer shares is restricted in manner hereinafter *Private Company* prescribed;
 - the members of the company (exclusive of persons who are in the employment of the Company) is limited to fifty, PROVIDED THAT, where two or more persons hold one or more shares in the Company jointly, they shall, for the purpose of this Article, be treated as a singlemember;
 - c) any invitation to the public to subscribe for any shares or debentures of the company is prohibited; and
 - d) the Company shall not have power to issue share warrants to bearer.

SHARE CAPITAL

4. The authorized share capital of the Company is Tanzania Shillings Fifty
Million (TZS 50,000,000/-) divided into One hundred (100) Shares of Share Capital
Tanzania Shillings five hundred Thousand (TZS 500,000) each.

LOANS BY THE COMPANY

5. No part of the funds of the Company shall be employed in the purchase of or in loans upon the security of the Company's shares. The Company shall
